**Theresa Siaw (BUS '10)** likes a challenge. As the founder of the OMNI Medical Student Training Program, which assists students who have trained at foreign medical schools to prepare for residency in the United States, she has directed her entrepreneurial

spirit toward helping aspiring physicians achieve their dreams.

Now she is taking on the stubborn issue of homelessness.

Siaw was recruited recently to serve as president of Bootstrap Villages, a Chicago-area nonprofit that seeks to provide housing and other services to help people experiencing homelessness get back on their feet. The latest initiative Bootstrap Villages is investigating involves building tiny-house villages.

Instead of the high-rise solution to affordable public housing from the 1950s that ended in failure, the organization "came up with mini homes on less than an acre—a city lot," Siaw says. "I thought that was a great idea. I thought it was something that maybe everybody would protest, but actually, a lot of people loved the idea."

Siaw was born on the Southeast Side of Chicago. Both of her parents are African immigrants from Ghana who encouraged her to get a good education. Immediately after graduating from DePaul with a bachelor's

degree in multicultural marketing, she began working in community health care in underserved communities. She currently sits on the board of Roseland Community Hospital on Chicago's South Side and is looking at neighboring vacant land owned by the city as a possible site for the mini homes.

"We still have to get City Hall and the Department of Planning and Development to approve the plan and change the zoning for these homes," says Siaw. "We're also trying to secure funding. Even though it costs probably less than \$5,000 to build a mini home, it costs a lot of money for the architect, environmental remediation and back taxes and bills."

Nonetheless, Siaw remains optimistic. "Mayor Lori Lightfoot ran on trying to help the homeless. We want to make sure that she lives up to that promise," she says. "We hope she can start with a Bootstrap Villages pilot program. In less than a year, we should be able to have a concrete plan so we can move forward."

Normalcy during the COVID-19 pandemic? That's precisely what the National Women's Soccer League had in mind when they held their Challenge Cup tournament June 27–July 26 in Salt Lake City. Not only were they the first pro league in the world to complete a season, but they managed it without a single novel coronavirus transmission.

Former DePaul soccer stars **Sarah Gorden (CMN '15)** and **Kelli Hubly (CMN '17)**, who play for the Chicago Red Stars and the Portland Thorns, respectively, played in the tournament. The Red Stars advanced to the finals, only to be bested by the Houston Dash in a match that drew a national television audience of 653,000.

To pull off a safe tournament, players from eight teams were secluded in a bubble with tight restrictions. "We were forced to stay in one place, but all of us made that commitment to our teammates and the league.

"We were tested all the time," says Gorden. "No one could hang out with members of the other teams at first."

When the Red Stars faced the Portland Thorns, Gorden didn't get a chance to match up on the pitch with her former DePaul teammate.

"That was our second game in four days, so our coach rested the starters and played most

of the rookies," Gorden says. "Even though I didn't play in that game, Kelli and I connected. It's always great to see her."

Although the Thorns were defeated in the semifinals by the Dash, Hubly says, "I actually really enjoyed competing in the Challenge Cup. The league was so good about keeping everything really organized and safe.

"Life in the bubble was interesting and different," she continues. "We basically played soccer, ate and hung out with teammates. A lot of Netflix was watched and lots of card games were played. We also did a tie-dye night with my team, which ended up being really fun."

Hubly and Gorden both acknowledge the lasting impact of their time at DePaul.

"Playing soccer at DePaul is really the reason why I am playing professional soccer," says Hubly. "I sort of lost my love for soccer before transferring. But I ended up falling back in love with soccer. I had so much fun that I didn't want to be done after my senior season."

"I went through a lot of adversity at DePaul," Gorden says. "A lot of my maturing and being able to overcome challenges in life is because of the way I developed as a person at DePaul. I couldn't have done it without all the great support I received while I was there."
