## In Honor of Arthur Anderson

**W**ITH THE close of the academic year 1968-1969, the College of Law watched the close of the teaching career of Professor Arthur Anderson. The experience was bitter-sweet. While all wish him well, the Law School suffers an irreplaceable loss with his retirement.

It would be an impossible task to try to list his many accomplishments over the years or to adequately describe the contribution he has made to the legal careers of the thousands of attorneys who studied under him. Being a student in one of his classes was a meaningful experience. The students who were in his classes ten, twenty, even forty years ago still remember his impact upon them.

Professor Anderson was born in Chicago. He received his Ph.B. (1921) and J.D. (1923) degrees from the University of Chicago. His career at De Paul began in September, 1930 as a part-time instructor. Being a conscientious and determined individual who has always sought excellence in his pursuits, while teaching, he returned to his alma mater and received his J.S.D. degree in 1936. At this point, he became a full-time faculty member.

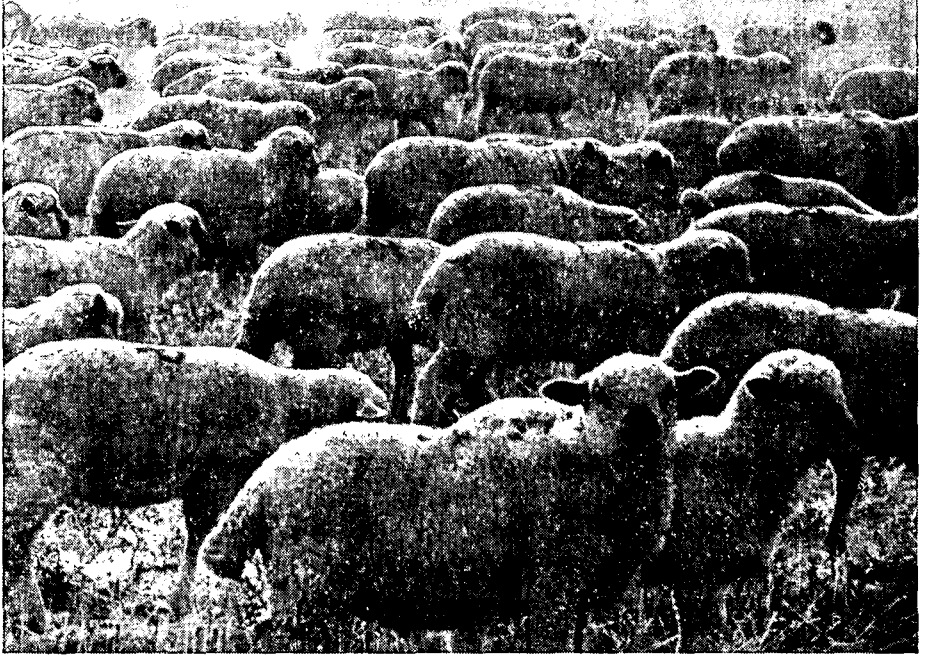
He left De Paul in 1941 to serve as dean of the newly formed Southeastern Law School. When the school closed because of the advent of World War II, Professor Anderson volunteered for the Navy and held the rank of Lt. Commander. At the war's end, he returned to De Paul.

An adequate description of the man, Arthur Anderson, is impossible. From the lips of each of his former students comes a slightly different version—a different experience recalled. However, each knows and remembers him as a gentleman, a scholar, and a teacher par excellence.

Some remember his promptness and recount how he would arrive at class at precisely the same moment each day. Others recall his precision and thoroughness and tell how he would, months in advance, infallibly forecast the day and hour at which a topic would be covered in class.

Commenting upon his teaching career, Professor Anderson said: "I have enjoyed life, the students, the faculty and the courses which I have taught." He brought to bear extraordinary talent, intellect, energy and concern to each—the students, the faculty and his courses.
